



## Schedule of Programme Fees\* Gender Identity Healthcare

\* 'Programme Fees' mean fees payable to the University which include, where applicable, module fees, practicum fees and resit fees as indicated below.

**Important:** the table below does not include fees payable to a third party, such as fees charged by your local examination centre, or local VAT, [Goods or Services Tax \(GST\) or sales tax](#).

**The Programme Fees below refer to the September 2020 and February 2021 sessions only and are effective from 1 March 2020.**

### Goods and Services Tax (GST)

The University is required to add Goods and Services Tax (GST) to registration and module fees paid by students residing in certain countries. Further information can be found on our [web page](#).

All Programme Fees shown are net of any local VAT, Goods and Services Tax (GST) or any other sales tax payable by the student in their country of residence. Where the University is required to add VAT, GST or any other sales tax at the local statutory rate, this will be added to the fees shown during the payment process. For students residing in the UK, our fees are exempt from VAT.

### Programme Fees may be paid in one of two ways:

Either a single payment when you initially register for the programme covering all module and practicum fees for the PGDip or PGCert or for a stand-alone Individual module.

Or, at your initial point of registration, the fee for the modules or practicums\* that you wish to study in that study session. To be registered, you must pay the fee for at least one module or practicum. In subsequent study sessions, only the fees for any new modules are payable.

\* Practicum 1 can be completed over the course of two study sessions. Practicum 2 can be completed over the course of three study sessions. Students should register and pay the

associated fee at the point at which they register for the Practicum. No further fees will be required in subsequent sessions.

Additionally, where applicable and subject to the regulations, you may be required to pay:

- A module resit fee when registering for a previously failed module
- A practicum resit fee when registering for a previously failed practicum

### **When to pay**

The closing date for initial/module registration for the September 2020 session is 24 August. You must have paid your Programme Fees (module and/or module continuation fees) by the registration closing date for your chosen study session.

### **How to pay**

Generally, students whose fees are paid by sponsors will be expected to correspond directly with their sponsor regarding Programme Fees. The University can provide an invoice, if needed, upon request. Materials will not be despatched and VLE access will not be available until Programme Fees have been received.

### **Fee increases**

Programme Fees are subject to annual revision and typically may be increased by up to 5% per annum.
