

STUDENT PRIVACY NOTICE – UNIVERSITY OF LONDON INSTITUTE IN PARIS

During the registration process you will be asked to provide some personal information for our records. The statement below explains how the University will process this data. Your application data will form part of your student record. You will find data protection referred to in your terms and conditions.

As a University of London Institute in Paris, student, you are registered with the University of London and your data will be processed by the University, a data controller under the definitions of the General Data Protection Regulation.

The data we collect

The University collects the following data:

- · Contact details, date of birth
- Academic history before the University, including references where required
- Financial details for fee payments
- Data about you generated during your time with us (study and assessment)
- Where relevant, information related to special exam arrangements or mitigating circumstances
- Data on how you access or use our resources (library, websites, virtual learning environments)
- Health or welfare information

What we do with your data

The University processes the information for the following purposes:

- Managing your application to study with us
- Managing your time with us a student (study and assessment)
- Carry out reporting and analysis on our student body to check and monitor our outcomes
- Telling you about other courses and services open to you
- Monitoring your interactions where you appear to have disengaged with your studies, we may contact you and offer support
- Sharing your contact details with the ULIP Student Union to allow you to make the most of your membership



The legal basis we use to process your data

The University has to have a legal basis for processing your data and relies on the following approach:

- For the majority of the processing of your personal data, collecting and maintaining the data is necessary for the <u>performance of your contract</u> with us as a registered student
- Where you access certain optional services we will ask for your consent
- Holding records of your qualifications is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller
- Making your research outputs (e.g. such as your thesis) available in the Institute library and SAS Space repositories is necessary for the performance of a <u>task carried</u> <u>out in the public interest or in the exercise of official authority</u> vested in the controller
- Providing data to relevant statutory bodies such as the Higher Education Statistics Agency (HESA) is necessary for the <u>performance of a task carried out in the public</u> interest
- Where you provide health information, for example to request special examination arrangements or raise accessibility issues we will rely on our <u>meeting our obligations</u> <u>around social protection law</u>, including such legislation as the Equality Act 2010
- Where you provide equality and diversity information we will ask for your <u>explicit</u> <u>consent</u> and use it for <u>statistical purposes in the public interest</u> as part of our duties to monitor equalities information
- Where we share information with others in a medical emergency or serious welfare
 or safeguarding issue we are doing so in order to <u>protect your vital interests</u> where
 you are not in a position to give consent
- When we share your name and contact details with the ULIP Student Union, we share this for the legitimate interests of the University and student union in ensuring that the relevant support networks are available for all students.



How long we keep your data for

Your data will be stored for the duration of your registration. After you graduate or cease your studies we will take the following approach:

- A transcript record of your results and qualifications will be kept permanently by the University.
- Postgraduate theses and formal dissertations will be kept in the University Library and be available to access
- We will retain your other academic work for as long as the time you have to make an academic appeal. When that time has passed we will securely dispose of it.
- We will retain other data collected on you for appropriate periods based on risk and necessity.
- On graduation or completion of your studies you automatically become an alumni of the University of London and a member of its Alumni Network. For further information on how your data is stored please see: https://london.ac.uk/support/development-office-data-protection-statement

Sharing your data with Queen Mary University of London

The Institute works in partnership with Queen Mary University of London (QMUL), a member institution of the federal University. In order to deliver our academic courses, we will share your registration, progression and academic performance details with QMUL as required.

Sharing your data with the University of London Institute in Paris Student Union

As a student you automatically become part of the ULIP Student Union (SU), which aims to enrich the unique experience that ULIP offers through student to student support and activities. It is governed entirely by students and exists to ensure fair representation for all. The University provides your name and email address to the SU at the start of your studies. If you would not like to be a member you can request the SU to remove your details.

Sharing your data with third parties

The University has to provide data to the Higher Education Standards Agency (HESA) for statutory reporting. You can view the HESA Collection notice at the following link: https://www.hesa.ac.uk/about/regulation/data-protection/notices

The University may use an external contractor or 'data processor' to store or manage its data. It will process this data only for purposes specified by the University and will be bound by contract to meeting the University's obligations under the General Data Protection Regulation. Where data is passed outside the EEA, the University will take the relevant steps to ensure there is adequate protection in place.



Your personal data will not be passed to any other third party without your consent, except where the University is required to do so by law.
